Co-ordinator's Progress Report: 4 November 2010 – 2 March 2011

Introduction

This report presents a brief summary of the activities of the Biodiversity Co-ordinator over the period from 4 November 2010 to 2 March 2011. As with previous progress reports, it is presented using the template from Natural England, which is now in use by a majority of LBAP partnerships across the country.

Additional information is presented in a series of annexes: Annex 1 presents a summary of the issues addressed at recent Topic Group meetings; Annex 2 presents a summary of the recent project proposals considered by the Biodiversity Project Fund; and Annex 3 presents information about forthcoming biodiversity events.

Highlights

• <u>Breckland Biodiversity Audit</u>: The principal highlight of this reporting period was the formal launch of the Breckland Biodiversity Audit at an event in Thetford on 30 November 2010. In addition to Dr Paul Dolman from UEA, speakers included the former Chief Scientist of Natural England (Tom Tew), the Chief Executive of Plantlife (Victoria Chester) and the Forestry Commission's Senior Ecologist (Jonathan Spencer). The audit confirmed that Breckland is a nationally-important biodiversity hotspot. Nearly one million records were collated by the study. These revealed that some 12,500 species have been recorded from Breckland, including nearly 2,000 species of conservation concern and 28 per cent of all BAP species. The audit has received a large amount of interest and attention, and has been given extensive coverage in both the local and national media. The audit has also inspired a similar exercise to be undertaken in the Broads. The audit's Commissioning Group is continuing to meet in order to take forward the findings from the study, and both the Forestry Commission and Natural England have begun to implement some of the report's key recommendations. Priorities for the Next Four Months

Priorities for the coming four months (March – June 2011) will include:

- Finalising a proposal to the Interreg Two Seas Programme for work on invasive alien species;
- Taking forward the recommendations of the Breckland Biodiversity Audit;
- Initiating arrangements for events such as Natural Neighbours, the Community Biodiversity Awards, the Planning and Biodiversity Seminar and the Annual Biodiversity Forum.

Other Activities:

- Norfolk Non-native Species Initiative: NNNSI has continued to make good progress over the winter months, despite it being a period when many invasive species are dormant and little control work can be carried out. Some highlights have included:
 - Overseeing the final stages of a number of practical control and eradication projects, including the control of floating pennywort on the River Waveney (reports on this and several other projects are now available on the NNNSI webpage);
 - o Publishing the 5th NNNSI Newsletter in December 2010, which received positive feedback from a range of stakeholders;
 - The NNNSI Co-ordinator giving a talk at a recent Wensum NFU Meeting, an important step in engaging more closely with the farming community and facilitating more strategic control of Himalayan balsam across the Wensum catchment;
 - Attending the National Workshop for Local Action Groups tackling Invasive Non-native Species, where the NNNSI Co-ordinator facilitated a workshop on obtaining funding.

Over the coming months, control and eradication projects will once again get underway, and there is a considerable amount of planning still to be done. In addition, a new project called 'Broad Sweep' (funded through the Broads SDF) will be launched in June. This project aims to improve knowledge of the distribution of invasive non-native species in the Broads (through a 'citizen science' survey), facilitate 'community action days' at a number of sites in and around the Broads, pilot a garden centre accreditation scheme and exchange experience between NNNSI and the New Forest Invasive Plants Project.

• Norfolk Bat Workers' Conference: In collaboration with the Norfolk and Norwich Naturalists' Society and the Biodiversity Partnership, NBIS organised the second Norfolk Bat Workers' Conference on 19 February. The full-day event attracted over 60 participants, and featured presentations on the Norfolk bats and churches project, the Barbastelle Study Group, the Norfolk Bat Group, and the spatial dynamics of the serotine bat in England.
